

## TERMS OF SERVICE

### 1 Acceptance of the Terms

These Terms of Service (“**Terms**”) describe how you can access and use the Finnlines application (“**Finnlines App**” or “**App**”). Finnlines App is provided by Finnlines Plc (Business ID FI02011539), located at Komentosilta 1, 00980 Helsinki, Finland (“**Finnlines**”).

By using the Finnlines App, you agree to follow these Terms. These Terms form a binding agreement between you and Finnlines.

When you register and click “I Accept,” you confirm that you have read and agree to these Terms. If you do not agree, you may not use Finnlines App.

Finnlines may update these Terms from time to time to reflect changes in its business, laws, or for other reasons that Finnlines deems necessary. By continuing to use the Finnlines App after any changes, you agree to the updated Terms.

### 2 Use of the Application

Finnlines gives you a personal, worldwide, non-transferable, and non-exclusive right to use the Finnlines App. The application is intended for your own personal use only.

You must use the Finnlines App in line with these Terms and all applicable laws and regulations. You agree not to use the App for any unlawful purpose or in any way that is not allowed under these Terms.

When you register in the Finnlines App with your Star Club ID, you must check that your information in Star Club Loyalty Programme is accurate and complete. You are responsible for keeping your password secure and for all activity under your account. If you notice or suspect any unauthorized use of your account or password, you must inform Finnlines immediately.

It is prohibited to copy or reproduce any portion of the Finnlines App in any form, and to publish any portion of the Finnlines App in any way. The application may not be copied or used to build a similar product, service or function. It is also prohibited to try to gain unauthorized access to the Finnlines App or help others do so. The application may not be made available to unauthorized third parties.

### 3 Intellectual Property Rights

You agree that all rights, title, and interest in the Finnlines App, including all intellectual property rights, data, and documentation in the App, are owned by Finnlines or its partners and will remain so. These Terms do not grant or transfer any intellectual property rights to you in any way.

All trade names, trademarks, and product or service names displayed on the Finnlines App belong to Finnlines. They may not be used without Finnlines’ prior written consent. Use of the Finnlines App does not give you any right or license to use these names or trademarks without such consent.

Finnlines may collect information about the use of Finnlines App and related statistical data and may process and analyze this information. By using the App, you agree that such data will be assigned to Finnlines. Finnlines will own all rights, title, and interest in this data and may use it in its business development.

#### **4 Data Protection**
